I understand and accept the following conditions if this open enrollment request is granted:

- 1) Approval to attend a school in an area other than that of the student's "assigned school" will, in effect, change the student's "assigned school" to that of the school for which open enrollment is granted.
- 2) My child may not return to his/her neighborhood school or any other Douglas County School without once again applying for open enrollment during the regular open enrollment window for the next school year. A change in level is the exception to this condition (see #3).
- 3) My approved open enrollment application will be valid for attendance at that school throughout the grades served by the school level. I must reapply for open enrollment to the next level. After leaving the elementary level, a student must reapply for open enrollment at the secondary level (grades 7 through 12 or grades 6 through 12 within a feeder with a 6th through 8th middle school grade configuration).
- 4) Approval of this request is based upon the space available in the receiving school. If the number of eligible applicants exceeds the space available in a program or school the priority system outline in Policy JCA/JFB shall be followed. I agree to accept any track assignment.
- 5) I am responsible for transporting my child to and from school. I also understand that this agreement does not guarantee my daughter and/or son will be issued an on-campus parking permit if s/he will be transporting her/himself to school.
- 6) Both parents must sign if there is a custody order and/or divorce decree that gives shared decision making to both parents. Failure to do so may result in the District rescinding acceptance of this application and subsequent placement.
- 7) **High School Only Note:** A student who transfers to a different high school without a Bona Fide family move over the summer will have restricted eligibility for the first 50% of the season in the upcoming school year in those sports (sponsored by the CHSAA) in which they participated during the calendar year preceding the transfer.
